Canaan Township Board of Trustees Regular Meeting May 11, 2021 Minutes

Chairman John Bayles called the meeting to order at 7:00 PM. Roll call showed all trustees and the fiscal officer present. Also present was Gene Ebert of Ebert Mowing and Landscaping and the following representatives from Iberia Joint Fire District: Chief Keith Beck, Steve Smith, and Fiscal Officer Brenda Miller.

Chief Beck reported the department has a total of 19 fire fighters. He also reported that last year they were able to replace a 1994 engine with a newer 2019 engine. Run reports for the last two years were also presented. The contract the township currently has with the Iberia Joint Fire District expires on December 31, 2021. Mr. Beck invited the trustees to come to any future meetings and also to come check out their new engine and equipment.

Mr. Ebert reported that everything is going well with the mowing. Mr. Ebert also inquired about a sub-contractor working under him in his absence. It was determined that the contract allows that.

The fiscal officer presented the minutes from the April 13, 2021 meeting. Mr. Sayers made the motion to approve the minutes. Mr. Carwell seconded the motion. Motion passed.

The fiscal officer reported receipts and balances to date in all funds. The bank reconciliation report was also presented. Automatic drafts were examined. The United Bank Statements were also distributed. Credit card purchases for April and early May were reviewed and the attestation statement signed by Mr. Bayles. Mr. Carwell made the motion to approve the reports. Mr. Sayers seconded the motion. Motion passed.

The roads were checked on Wednesday, May 5, 2021. The Road Sign Inventory and Management form was completed and is on file.

Mr. Sayers reported that the meeting for 1st Consolidated Fire District was business as usual with nothing new to report.

There was no Regional Planning update.

Kokosing won the county bid for paving projects and 20/20 Enterprises received the county bid for chip and seal. The paving bid is \$53 per ton. Canaan Township will piggy back off the county for all paving and any chip and seal projects done this summer.

The trustees are considering the following roads for paving this year: Twp. Rd. 71 (between CR 59 and TR 10), Twp. Rd. 72 (between CR 59 and CR 61), Twp. Rd. 74 (between CR 131 and CR 69), and Twp. Rd. 65 (between TR 60 and TR 66). This is approximately 3.37 miles of paving.

Mr. Carwell made the motion to approve the bills for payment. Mr. Bayles seconded the motion. Motion passed.

There being no further business to come before the board, Mr. Carwell made the motion to adjourn. Mr. Sayers seconded the motion. Motion passed. The meeting adjourned at 9:00 PM.
